2.1. Hallam Union reserves the right to refuse unsuitable copy/artwork.

2.2 Advertisers will receive a free copy if requested.

2.3 It is the advertisers' responsibility that their product/brand/service or company is not in breach of the Trade Descriptions Act 1968 or any other subsequent act. Furthermore it is their responsibility that the information contained in the promotion is accurate and complies with the law.
